POLICIES & PROCEDURES

Vaccinations: All animals over twelve weeks of age are required to have their rabies vaccination. A copy of your up-to-date immunization records will be required. Puppies will not be seen or allowed into services until they have had their 3-series of puppy shots. Please be sure your animals are current with all of their vaccinations for the wellness of their general health and all who come into contact with them. Also, please let us know of any health issues that your pet may currently have. No Kennel Cough (Bordetella) vaccine is allowed. If you do get this vaccine, you must wait 15 days before using any services. **Grooming:** Dogs must be appropriately groomed & clean upon arrival. **Spay/Neuter:** All dogs that use these services must be spayed or neutered. **Flea protection:** All dogs must use monthly flea/tick protection throughout the year. It is your choice what you use, but you must ensure that it works. **Dogs at Play:** Please note, when dogs engage in play with each other they use their mouths and bodies. You may see the occasional scratch. Dogs are dogs and their play is such. Be aware there are inherent risks of illness, injury or death when dealing with animals. If your dog(s) injure(s) another dog(s), the owner of the dog(s) is solely responsible for the vetting and bills of the injured dog. Your dog will also be reported to animal control. Go Doggy is not responsible and cannot be held liable. You agree to this and all policies, terms and conditions by signing this contract. Also, please be aware that this is an open environment, meaning nature can be a bit dirty. Your dog may come home dirty after playing for a day with other dogs. A dirty dog is a happy dog. **Payment for Services:** Each time services are used payments are to be made in full prior to your departure. Cash only. No refunds on any service.

BnB (payments/cancellations): A portion of BnB payments are always due when you book your BnB. Dates are not held until until non-refundable deposit is recieved (must recieve within 48 hours). If deposit is not recieved within 48 hours, the dates are open for other clients to book. Non-refundable deposits can be made by check and made payable to Kathy Nobrega. There will be a \$40 handling charge, in addition to any charges presented by the bank, for checks returned. The non-refundable deposit can be mailed in check form (made out to Kathy Nobrega to ●●●●●●●●●●, Punta Gorda, FL 33955. The remainder of the BnB payment is due upon drop off at the beginning of your dog(s) BnB stay. **THIS IS A CASH ONLY PAYMENT.** If you cancel your BnB stay, you will not receive your BnB non-refundable deposit back. You will not have to pay the remainder of what it would have cost you for the total stay but you will loose your non-refundable deposit. If you choose to cancel mid-way through the BnB stay (example: you come home early), reimbursement of any monies is not allowed due to the time being reserved for you. **Reservations:** Please try to make all BnB reservations at least 3 weeks in advance. Of course, I am flexible and if I have space at the last minute, I will accommodate you. **Feeding:** You must bring your own dog food and treats. Please bring enough food to last throughout their stay. Also, please realize your dog will lead very active lives with me, so always pack a bit more than you would have in your normal day-to-day life for your dog(s) If feeding is specific, all foods must be in prepackaged ready to go meals. (example: some clients feed only human food - this must be cooked and prepared and diced out into ziploc bags or large tupperware bowls.) Some clients do rotisserie chickens, these must be picked apart and bagged as well. Please do not bring a whole chicken, etc. If your dog should run out of food, then they will be fed from my dogs feed (with payment due from you upon your return \$2 per meal). If your dog needs a specific food due to allergies, then please ensure you pack enough of it. **Adjustments:** Some dogs live sheltered lives with little variation or exposure to new adventures At Go Doggy a big new world is offered to them and they may on a rare occasion experience a temporary loose stool or vomiting due to this change **Allergies:** If your dog(s) suffers from food allergies, I will make every attempt to keep these foods from them. However, I cannot guarantee you that your dog will not get into another dogs food bowl or grab a treat that might be laying about on the floor. If your dog has a terrible, life threatening food/allergy, then please consider having them stay with a relative, pet sitter or in a kennel for I cannot guarantee they will not get into another food source.

TERMS & CONDITIONS

The parties herein agree as follows:

- 1.) Go Doggy/Kathy Nobrega (herein known as Go Doggy) is authorized to perform care and services as outlined in this contract. Go Doggy is also authorized by signature below to seek emergency veterinary care with release from all liabilities related to transportation, treatment and expense. Should specified veterinarian be unavailable, Go Doggy is authorized to approve medical and/or emergency treatment (excluding euthanasia) as recommended by a veterinarian. Client agrees to reimburse Go Doggy for expenses incurred, plus any additional fees for attending to this need or any expenses incurred for any other home/food/supplies needed.
- 2.) Go Doggy agrees to provide the services stated in this contract in a reliable, caring and trustworthy manner. In consideration of these services and as an express condition thereof, the Client expressly waives and relinquishes any and all claims against said Go Doggy except those arising from negligence or willful misconduct on the part of the Go Doggy company.
- 3.) Client understands this contract also serves as an invoice and takes full responsibility for PROMPT payment of fees before start of services contracted. Prepayment is required. Cash is the preferred payment method. A handling fee of \$40.00 will be charged on all returned checks. In the event it is necessary to initiate collection proceedings on the account, Client will be responsible for all attorney's fee and costs of collection.
- 4.) All pets are to be currently vaccinated. Should Behaviorist be bitten or otherwise exposed to any disease or ailment received from Client's animal which has or has not been properly and currently vaccinated, it will be Client's responsibility to pay all costs and damages incurred by the victim.
- 5.) Go Doggy Company reserves the right to terminate this contract at any time before or during its term if Go Doggy, in its sole discretion, determines that a danger exists to the health or safety of Behaviorist or others. If concerns prohibit from caring for pet, Client authorizes pet to be placed in a kennel, with all charges to be charged to Client. Every attempt will be made to notify Client regarding such a situation.
- 6.) Client authorizes this signed contract to be valid approval for future services of any purpose provided by this contract permitting Go Doggy to accept telephone reservations for service without additional signed contracts or written authorization.
